On the ground that has been laid at present for the continuous stimulation and promotion of the success of communist revolution to be achieved in the future, and, the successive and sustainable development and improvement of the communist consciousness invaluable for the overall and profound prosperity of this community in future communist society, it will be understandable that the abundance of communal resources as engendered by the successful and sufficient development and improvement of present

technologies will give a very strong ideological and epistemological impetus to the true ideological and epistemological liberation of man in the future when they are able to strike an acceptable and admirable balance between "the tension between individuality and collectivity (ibid, p. 195)" that is valuable for them to avoid falling victim to the interpersonal complexity characterizing impressive and imaginative interpersonal distortion, discrimination, devaluation, oppression, exploitation, and, alienation they have been suffering at present when they have to be faced with the increasing competition for the scarce resources they rest on a lot to make a living. The reason is that the achievement of this balance is inclined to play an important role in the salience of the liberty of man, the equality of man, the fraternity of man, and, the dignity of man on the basis of the courage and confidence they have picked up from this tremendous progress that is inclined to epitomized in the interpersonal simplicity of them in future community where the abundance of various source turns out to be translated "from fiction into fact (ibid, p. 201)". In view of the similarity between what has been highlighted in this liberation, it will be made possible to make a good analysis of the promotion of the virtues of man as exemplified in the analytical evidences dispersed in *The Last Man*.

Indebted to the interactive imagination, inspiration, and, illumination acquired between the very good faith in the existence, essence, and, innocence of man elaborated in the previous and present studies of Marxists like Olufemi Taiwo in the theoretical and practical rejection to the pessimism that has been imposed upon human existence, human essence, and, human nature in an illogical fashion, and, the ignored optimism caged in the popularization of the pessimistic views of the views, values, and, virtues of man in *The Last Man*, this article will clarify the theoretical and practical feasibility for the essential transcendence of the views, values, and, virtues of man on the way to the subversion to the pessimistic fallacy popularized in the interpretation of this science fiction indebted to the theoretical edification of legal naturalism and the practical instruction of the illogical fallacies showing up in the explication of this science fiction.

### 4. The Practical Feasibility of the Essential Transcendence of Man Exemplified in The Last Man

The objective and evident justification of the existential and essential transcendence of man in terms of the views of man, the values of man, and, the virtues of man as has been reflected in the analytical samples to be picked out from this science fiction under the title of *The Last Man* in consistent with the respective elaboration of the evolution, promotion, and, liberation of man proposed and persisted in the construction and consolidation of the major theoretical frameworks and theoretical systems of legal naturalism with respect to the disappearance of law in communist society to be realized in the future will be achieved in the three major analytical steps to be taken to answer the three analytical questions raised at the outset of this study and reach the three analytical objectives set in the first part of this article as what to be demonstrated in a respective fashion in the following three dimensions in connection with the analytical samples that are inclined to be picked out from this science fiction to provide appropriate and adequate analytical evidences for the apparent and appropriate justification of the major argumentative

proposition proposed at the beginning of this article in an intuitional fashion that despite the uncertainty of human lots and the adversity they have to be faced with as clarified in this science fiction, it is of high probability that they are able to achieve their essential transcendence in terms of their views, values, and, virtues due to the evolution, promotion, and, liberation of man they are bound to acquire in their active adaptation to and transformation of the natural, social, and cultural environment in which they have lived and will live in the future.

4.1 The Essential Transcendence of the Views of Man in The Last Man as Inspired from the Evolution of Man

In correspondence with the very pessimistic desperation of the views of man cropping up in the interpretation that has been given of the theoretical and practical impossibility for man to continue their existence in the known world as indicated in the production of this science fiction owing to the true innocence exemplified in the ignorance of the existence and essence of man who are inclined to make ideological and epistemological breakthrough when they are faced with the unavoidable adversity that tends to give them a very strong impetus to the acquisition of the determination they need to seek for their prosperity in future society, an appropriate and adequate number of analytical examples will be found out from the narrative facts and narrative events recording the ideological and epistemological growth of the major characters as have been depicted in the practical production of this science fiction titled *The Last Man* to show the very essential transcendence of man in the case of the ideological and epistemological progress they have been making just as what to be expounded below in a respective fashion in line with what has been imprinted and impressed in this science fiction.

With standpoint of the demographic view of man, the first analytical example in this respect is closely related to the growing popularization of the terrible prophecy about the population on account of the failure to have a good understanding of the scientific inexplicability the great efforts made in the dialectical and objective attitude that has to be held towards the objective authenticity and authentic objectivity carried in the misleading perception of demographic phenomenon and the disappointing failure to have a profound access to the demographic essence as shown in the excessive exaggeration of the extinction of man in 2073 engendered in the natural disaster to happen in Naples where a fictional world has been imagined to be peopled with women rather than men to highlight the possibility of the discontinuation of the reproduction of man without knowing in an imaginative and insightful fashion that what to happen in Naples is not the case of that around the world. That means the shortage and impotence of man over there are not in a position to be considered to stand for what to happen to man throughout of the world. Moreover, even though it has turned out to be true that the destination of this travelling is Rome, what has to be known in the minds of the literary scholars and literary critics in a clear fashion dedicated to the interpretation of this science fiction that Rome is the genuine destination of this European travelling but not that of international travelling. To put it in another way, what has happened to the man of Europe with regard to the extinction of man is not supposed to be exaggerated to the very vicious

popularization of this European extinctive phenomenon around the world. To this extent, it has to be admitted in a rational fashion that the writer of this science fiction is indeed not in a good mood the moment she produces this science fiction when she feels extremely despaired at whatever happens to her living experiences, loving experiences, and, working experiences that give rise to her cynical articulation of her internal discontent with the world in a pessimistic fashion. Even it is the case from England to Naples, it is not necessarily the case with the entire Europe. To this extent, what has to be known in the mind of the readers of this science fiction is that it is not the man of the world nor the man of the Europe that have been faced with the unbelievable and incurable disaster of extinction and importance but the perceptive and cognitive horizon of this writer that is supposed to be broadened in an appropriate fashion to the effect that the genuine possibility for the development and improvement of the view of man have been neglected in an unreasonable fashion and in an unscientific fashion. Therefore, it has to be noted in a very clear fashion that although natural disaster has happened in the world in an inevitable fashion, the environmental adaptation to the worsening living conditions of man has given a much stronger impetus to them in a successive fashion, in a sustainable fashion, and, in a sufficient fashion right on the way to the increasing theorization and systematization of their views acquired from their ideological and epistemological evolution in a hopeful fashion.

For the sake of the medical view of man, the second analytical example in this regard is that it is of very high relevance to the blind exaggeration of the helplessness, hopelessness, and, homelessness engendered in the plague the travelers depicted in this science fiction has suffered from when they try their best to overcome the difficulty they have in their traveling experiences to enable them to pick up the courage and confidence they have to count on a lot to get hold of their health on account of their aimless underestimation of the successive and sustainable progress and transcendence of the medical technology in future society with respect to the treatment of incurable diseases and the promotion of the proportion of the reproduction of man by that time in spite of there being sterility because of the increasing deterioration of the health of man in an astonishing fashion, and, their unreasonable devaluation or even distortion of the medical views of man that are playing an increasing important role in the promotion of the reproductive rate of man and the reduction of the sterilization of man in a successful fashion and in a sufficient fashion indebted to what they are likely to benefit from the successive and sustainable enrichment and improvement of the ideological and epistemological encouragement and enlightenment of man that tend to give rise to the achievement of the admirable technological progress in the exploration and production of the valuable medicines in the process of the development and improvement of the crucial and conducive medication that can be used to alleviate the pains man have been suffering from the sterile diseases that have been torturing man and preventing them from the stable promotion of the population by that time as a result of the increasing permeation of the pessimistic cynicism about and disbelief in the stimulation and promotion of the medical views of man into the minds of an increasing body of literary scholars and literary critics who have been coated in the inexactness of their unscientific predictability and caged in their long imprisonment of the static and even dynamic status of the technological development of the time they have spent rather than that in the future. In this case, what has to be figured out from the look they have taken at the progress to be made in the future society is not far-sighted enough because it has turned out to be rather short-sighted for them to take a look at what to happen to them in the future according to what has been popularized at the moment they spent in the past or have spent for the time being rather than will spend in the future without knowing in a clear fashion that the objective and exact judgment to be made of what to happen to them is not supposed to be confined to what has been popularized in their previous and present lives in a mechanical fashion, in a dogmatic fashion, and in a ritualistic fashion in that it has to be taken into account in an insightful fashion that the true developmental and governmental view in relation to the development and improvement of medical technology is inclined to be enriched and improved owing to the implicit or explicit evolution of man that act as a very strong stimulus to the inspiration and stimulation of the improvement of the actual medical view of man in the society where they will live in future society.

In the case of the ideological view of man, the third analytical sample available for the genuine justification of the high practical feasibility for the final and formal achievement of the essential transcendence of man with the help of the gradual and graceful evolution of man that is inclined to give rise to the ideological and epistemological enrichment and improvement of man closely related to the progression and promotion of the view of man, has a lot to do with the narrative fact that although he has been surrounded with the loneliness and indifference of the known world he has lived for a very long time in a hopeless fashion, in a helpless fashion, and, in a homeless fashion owing to the failure of man in the concretization and crystallization of what has been seen in the misleading conceptualization of the known world they have been accustomed in an expected fashion as a result of the pessimistic popularization of the increasing destruction of this known world filled with strings of narrative events made full use of in the extensive or excessive transmission of social cynicism, cultural cynicism, medical cynicism and, ideological cynicism as engendered in the spread of the unscientific suspicion of the genuine existence and essence of man rooted in the gradual growth of the very superstitious predictability of a great many social, cultural, medical, and ideological fortune-tellers who have a very good understanding of the perceptive and cognitive poverty and sterility of man, it has turned to be very hopeful for the protagonist of this science fiction Lionel Verney to sense the genuine ideological and epistemological encouragement and enlightenment from the narrative event that has acted as a narrative suspension revealed at the end of this science fiction that he has to be faced with the uncertain embankment on the unknown shores after the extinction of the rest of members of his traveling team who have turned out to rub shoulders with the benefits they ought to have offered in an unknown time in the future. From the perspective of the narrative optimism euphemized in the very profound and perspicacious interweavement of the rich narrative thoughts and narrative insights as have turned out to be very crucial and conducive for the enrichment and improvement of the views of man in the production of this science fiction, what has to be zoomed in on in the interpretation of the intentional or unintentional mention made of the unknown shores at the close of this science fiction is that the revelation of the uncertain existence of this unknown world is exposed to the vast majority of the world in an ambiguous fashion that there will be uncertain experience of man except for the certain one existing the known world in which his travelling teammates have been engaged in a direct fashion or in an indirect fashion in that he is inclined to run across man in this unknown world in the future as long as he is willing to pick up his very great perceptive and cognitive courage and confidence to make an exploration of the further development and improvement of the view of man who have been making their way to their evolution in this unknown world in an optimistic fashion. To this extent, it is inclined to be seen in an apparent fashion that the discoveries of the essential existence of man in this unknown world will be bound to show that it is unnecessary for man to be lost in the pessimism that has turned out to be characterizing the minds of those fatalists who have expected little of man due to their being determined to get used to the dominative and manipulative popularization of escapism and pessimism in the known world that has run out of the curiosity of man and the opportunity they are likely to get hold of to help them to have a very good ideological and epistemological progress of them in line with the pace in which they ought to have kept with the gradual evolution of man with respect to the stable improvement and enrichment of the views of man that turn out to be bound to be very valuable for the fulfillment of the genuine essential transcendence they have been expected to set their feet on in an ambitious fashion and in an aggressive fashion.

On the basis of the theoretical and practical support offered in the justification of the possibility for the achievement of the development and improvement of the views of man, it is natural for one to see that the overall and evident perception of the evolution of man is quite conducive for him to have a very good knowledge of the progression and promotion of the essential transcendence of them indebted to what has been actualized in the evolution of men in the process of their making great progress in the promotion of their demographic view, medical view, as well as, ideological view of the correspondent development of future society.

an increasing number of literary scholars or literary scholars who have been confined to the very superficial exaggeration of the doomed gloom and gloomed doom man have to be faced with in their lives when the notion of the extinction of man has come to their mind in a pessimistic fashion and in a fatalistic fashion at the thought of and at the sight of the inevitable birth and death of them rather than the exaggeration of the discontinuation of either the limited or unlimited circulation between them in an correlative fashion and in a conducive fashion without having a very good access to the ideological and epistemological breakthroughs of man that are inclined to give rise to the gradual, gorgeous, and graceful refreshment, refinement, and, reinforcement of the ideological and epistemological pursuits of them as a consequence of their having turned a blind eye to either the intentional or unintentional trivialization of the true social values of man who have been suffering from the bearable or unbearable bitterness in addition to the very vicious loneliness that tends to be translated into the perceptive and cognitive quietness very valuable and veritable for the stimulation and promotion of the motivation and intention of perception and cognition they are supposed to make best use of the opportunities they are likely to catch hold of to develop and improve in their lives and experiences in a decisive fashion, in a diverse fashion, and in a distinctive fashion. This can be seen from the important role this perceptive and conceptive motivation and intention are likely to play in the transformation of the destruction of the social environments into the construction and reconstruction of them to provide them with a string of optimistic expectations when their minds have been permeated into the notion of the extinction of man and the deterioration of the social environment they have been resting on a lot for a good or better existence. However, it has been overlooked in the look taken at the miserable existence of man and the unbearable loneliness of them that the popularization of those pessimistic perception and cognition of man has tended to prevent them from having a profound and particular understanding of the genuine values man have been offering in a sensitive fashion and sensible fashion on account of their failure to have a very good knowledge of the authentic and objective reality that lead to the true understanding of the essential existence and existential essence of man in the process of stimulating and promoting the successive, sustainable, and, sufficient development and improvement of the social environment in which they have live. Therefore, what can be seen from the analysis made of above in accordance with what has been mirrored in the objective and dialectical attitude that is in a position to be developed, improved, and, held toward the miserable existence and veritable essence of man whose social lives have been filled with either known or unknown bitterness and loneliness that can be translated into the very great ideological and epistemological power to enable them to realize their social values in an optimistic fashion just as what has been euphemized in the rich traveling experiences and experiments of the protagonist of this science fiction by the name of Lionel Verney in a profound fashion and in a perspicacious fashion, for it is the final and formal realization of those social values that has turned out to be of very great practical importance for them to acquire their essential transcendence in the case of their enrichment and improvement of the social values they have created for the continuous promotion of the developmental construction and reconstruction of the social environment where they have to live in the long run or even

In the second place, the great emphasis to be attached on the systematic elaboration and explication of the theoretical and practical feasibility for the essential and eventual realization of the genuine potentiality of the cultural values of man for the ambitious and aggressive exploration to be made of the affective and marital vicissitudes penetrated into the intrinsic and extrinsic interweavement of the love and marriage of the characters depicted in the production of this science fiction under the title of *The* Last Man in an ingenious fashion and in an insightful fashion to highlight or even maximize the true cultural values exemplified in the cultural customs and cultural beliefs of those characters who have been considered as the remarkable symbol of the extinction of man in the form of the distinction what has been hidden behind the profound biological denotations and connotations of the absence of those women characters at the end of this science fiction has been making in the continuous enrichment and improvement of the ideological and epistemological ingredients of the cultural thoughts and cultural insights potentiated in the characterization of women in the production of this science fiction as a result of the very appropriate and adequate acquisition of the cultural essence and cultural quintessence as personified in the sweet love and happy marriage of those women characters in a symbolic fashion and in a sympathetic fashion, and instilled into the major narrative facts and narrative events of this science fiction with the help of the perceptive and conceptive illumination and inspiration concealed in the ideological and epistemological frameworks of legal naturalism related to the promotion of man in relation to the theorization of the ideological and epistemological components extremely valuable for the overall and essential perception of the true cultural values of man in the future society in a logical fashion and in a systematic fashion in reference to the very great impact the successive and sustainable implementation of communism in the future, has too much to do with the decisive resistance against the very superficial simplification of the painful experiences of those two women characters by the name of Adrian and Evadne and the exaggeration of their unbearable pains for the aim of seeking for the revelation of the cruel reality and realistic cruelty impressed in the thorough sterilization of the cultural values of man in relevance to the affective and marital customs epitomized in the loneliness, bitterness, and powerlessness of them engendered in the imperialistic devastation of the social order of the cultural environment in which they have lived for a very long time, for this has overlooked the possibility for the protagonist of this science fiction named Lionel Verney to catch hold of the opportunity to get in touch with the women who have been living in the rest of the unknown world in the future and to have a very good access to the reproduction of man over there in the future and the further realization of the cultural values that have failed to be fulfilled at present in the known world by the time he has been getting to a wonderland of the unknown world. With the standpoint of the objective authenticity and authentic objectivity of the matter in the future society to be taken into account either in a philosophical stance or in a logical sense, what has to be figured out in an apparent fashion is that it is not wise for a literary scholar or a literary critic to make a judgment of the cultural values of man in the future society as expounded in the increasing enrichment and improvement of the organic components of the cultural ingredients they are inclined to acquire and accumulate in the transition from present society to future society in the process of the absence of nation, class, and, law in the gradual implementation of the crucial and conducive thoughts and insights of communism into the social practices in the future just as what has been expected in the construction of the theoretical frameworks and theoretical systems of legal naturalism in an insightful fashion and in an ingenious fashion. For the sake of the perceptive and conceptive inadequateness, inappropriateness, and inaccurateness of the similar judgments made in the interpreting practices of a growing body of literary scholars or literary critics who have turned out to be lost in the disappointments at the inclination for man to maximize their cultural contributions to be sent to the development and improvement of the cultural thoughts, cultural insights, and, cultural pursuits of them in future society in a dynamic fashion in their explication and exploration of the cultural values of man exemplified in the production of this science fiction at the risk of the devaluation and distortion of the cultural values to be realized in the exploration man are inclined to make in the future, it has to be made very clear in the minds of those literary scholars or literary critics in a sensitive fashion and in a sensible fashion that it is the possibility for the protagonist to get hold of the opportunities to get in touch with the rest of women in the unknown world except for the women characters depicted in this science fiction that has revealed the probability for man to have a good access to the cultural beliefs, cultural mores, and, cultural pursuits epitomized in the realization of their cultural values in the view of the affective and marital delineation of the women in the known world and that of the women to be expected in the unknown world owing to their profound and perspicacious awareness of the harm this inappropriate and inadequate judgment is inclined to do to the successive, sustainable, and, sufficient perception and cognition of the true existence and essence of man who will intend to seek for their essential transcendence in the future society where their increasing ideological and epistemological independence

In the third place, in response to what has been indicated in the perception and cognition of the lives and lots of man exemplified in the critical practices and critical processes related to the very popular interpretation of the inappropriate and irrational devaluation and distortion of the ideological values of man personified in the gloomy thoughts that have been articulated in a very noticeable fashion in the production of this science fiction under the title of *The Last Man* in high relevance to the ideological structure and ideological framework of the pessimistic thoughts instilled into the very crucial narrative thoughts, narrative insights, narrative discourses, and, narrative voices of the narrators depicted in the systematic construction and formation of the aesthetic and artistic thoughts valuable for the cautious and curious enrichment and improvement of the ideological ingredients this science fiction has to be composed of in a logical way, in an organic way, and in a systematic way as what has been engendered in the blind exaggeration of the thorough extinction of them as result of the extensive popularization of the plague that gives rise to the eventual losses of the lives of the vast majority of man, it has to be argued in a rational fashion and in a reliable fashion that the excessive exaggeration of the extinction of man regardless of the possibility that the increasing development and improvement of the thoughts and insights of them in a systematic fashion and in a strategic fashion is inclined to give them a very strong ideological impetus to enable them to pick up the indispensable perceptive and cognitive courage and confidence to seek for the essential transcendence very valuable for the stimulation and promotion of the perceptive and conceptive motivation and intention of them to make an exploration of the unknown world, is, the inevitable product of the true failure of a good many literary scholars or literary critics who have been unable to see through the ideological and epistemological essence of them in a thorough fashion after having a profound understanding of the authentic and objective existence and essence of man in accordance with the ideological and epistemological phenomenon in which the ideological and epistemological quintessence of their very insightful thoughts and insights have been concealed in a confidential fashion, for those literary scholars have been dominated and manipulated in the ideological and epistemological pessimism and cynicism that have been inclined to pollute, to corrupt, and even to stupefy the minds of man in an unintelligible fashion at the cost of the exact stigmatization of the ideological values of man that has been believed to be likely to give rise to the traumatization of the souls of man in an incurable fashion notwithstanding the very great efforts that can be made for the elimination of it and the objectification of them in an irrational way to the very great extent that the incurability of

man and the cruelty of the objective reality have been exaggerated in a excessive fashion so that it seems to be very impossible for them to be able to make their way to the ideological and epistemological salvation that tends to pave way for the genuine realization of the dream of seeking for the essential breakthroughs on the way to their ideological and epistemological growth as long as a good look is inclined to be taken at the ideological and epistemological fertility in lieu of the futility of the narrators of this science fiction in an insightful fashion. In this sense, what can be edified in this analytical practices and process in a sensitive fashion and in a sensible fashion, is, that what has been implied in the authentic and objective narrativization of this science fiction where the ideological and epistemological profundity, particularity, and perspicacity of man have been euphemized or highlighted in an invisible way in the articulation of the narrative thoughts and narrative insights penetrated into the narrative practices and narrative processes of this science fiction in a confidential fashion, has turned out to be in agreement with what has been valued in the theoretical thoughts and theoretical insights enriched and highlighted in the popularization of the theoretical exploration of the progression of man to have a good access to the genuine theoretical potentiality for the ideological and epistemological promotion of man in the realization of communism in future society as shown in the very predictable exploration of legal naturalism.

Based on the respective review of the theoretical and practical potentiality for the enrichment and improvement of the social values, cultural values, and, ideological values of man particularized in the production of this science fiction and the construction of the theoretical frameworks and theoretical systems of legal naturalism pertaining to the promotion of man, it can be seen in a natural fashion and in a normal fashion that seeing that a very good preparation will be made for the stratification of the appropriate and adequate evidences dug out from the narrative facts and narrative events of this science fiction to make it consistent with the very impressive and imaginative theoretical encouragement and theoretical enlightenment of legal naturalism in relevance to the promotion of man in an optimistic way, what has been done in the rich analytical practices and analytical processes demonstrated above in the acquisition and accumulation of the analytical samples from this science fiction in an appropriate fashion and in an adequate fashion and the analytical evidence from the profound perception and cognition of the promotion of man persisted in the construction of legal naturalism, is inclined to lay a sound foundation for the authentic and objective justification of the practical and theoretical feasibility for the realization of the essential transcendence of man in relation to the promotion of their social values, cultural values, and, ideological values as a consequence of their acquisition of the very great ideological and epistemological breakthrough in their curious and cautious adaptation to the great changes taking place in future society.

4.3 The Essential Transcendence of the Virtues of Man in The Last Man as Instructed from the Liberation of Man

From the point of view of cynical criticism of the numerous vices of man in the previous and present exploration made of the omnipresent crises of man in connection with the existential crisis they have been faced with and have to be faced with in the perception and cognition of the nature, existence, and, essence of them in line with what has been simplified in the excessive exaggeration of those crises in the interpretation of the fatalistic distinction of man in view of what has been incorporated into the actual reinforcement of the strong gothic atmosphere in which this science fiction has been gloomed in an impressive fashion to make it clear that they are doomed to be faced with the eternal death in an unavoidable fashion, it has to be made in an obvious fashion in this study that an appropriate number of the analytical measures will be taken to seek for the appropriate and adequate collection of the valuable analytical evidences from the very profound and perspicacious perception of the narrative nutrients and narrative ingredients diversified and particularized in the organic and objective interweavement of the narrative facts and narrative events of this science fiction to lay a solid ground for the incorporation of those textual examples into the good cooperation of the valuable theoretical inspiration and theoretical illumination obtainable from legal naturalism to highlight the crucial and conducive virtues of man that are inclined to give rise to the essential transcendence of man in view of the liberation of man shown in the theoretical experimentation of legal naturalism in hope of the true ideological and epistemological promotion of man in future society in reference to the appropriate pace to be kept in with the natural and normal implementation of communism in future society right on the way to the ideological and epistemological refinement and reinforcement of their thoughts and insights to be articulated to show the concern for their dream of the ideological and epistemological liberation as what has been proposed in the continuous construction and reconstruction of the theoretical frameworks and theoretical systems of legal naturalism in the pursuits of the groundbreaking progress to be made in an appropriate way and in an adequate way to broaden their perceptive and cognitive horizon in future society in an insightful way just as what to be dwelled upon in the following three fold related to the implicit clarification of the creative virtues, critical virtues, and cautious virtues of man according to the analytical samples that are inclined to be picked out in a particular fashion from this science fiction to give an evident support to the logical, objective, and dialectical justification of the essential transcendence of man personified in the intensification of the rational and optimistic reflection and rumination of the lots and lives of man.

To begin with, from the point of view of the creative virtues of man that has been dwarfed and even devalued in the interpretative experiences and interpretative experiments in literary criticism dedicated to the blind exaggeration of the unavoidable extinction of man and their precious virtues when they are doomed to be faced with the irresistible natural disaster like earthquakes, floods, plagues, and as such without knowing in a rational fashion that those natural crises are not inclined to strike the globe at the same time either in a frequent fashion or in a regular fashion but the minority of the regions of it in an occasional fashion in connection with what has been exemplified in the extremely dreadful situation the

protagonist of this science fiction titled *The Last Man* by the name of Lionel Verney at the sight of the doom of the rest members of his travelling team in spite of their ignorance of what has been kept in his mind at the thought of the cruel reality and realistic cruelty he has been forced to be faced when it has been taken for granted in a very clear fashion that he can do nothing to change the known world rather than taken into account the courage and confidence he is likely to dig out from his very strong curiosity of the unknown shores he is determined to make an exploration of at the end of this science fiction, and, the objective fact that this travelling team depicted in this science fiction are by no means to be considered to be likely to stand for the vast majority of man throughout Europe let alone those around the world, what needs to be stressed in a clear fashion is that the vast majority of man are bound to make the best of their intuitive intelligence to deal with the terrible situation in which they have in an insightful fashion in addition to the artificial intelligence they have been developing and improving all the more in their living experiences and working experiences where they are most likely to stimulate and promote their curiosities and creativities that are inclined to give them a very strong impetus to work very hard to highlight their creative inclination to make an exploration of the unknown world and to maximize their respective creative virtues in a strategic fashion, in a logical fashion, as much as, in a systematic fashion according to what they have experienced in the known world after their having a very good access to the authentic existence and essence of man rather than the superficial phenomenon that has been keeping them from having a very profound understanding of the profundity, perspicacity, and, particularity of man, or, what they have foreseen in the perception and cognition of the objective truth of the unknown world that tends to enable them to make much greater progress in the enrichment and improvement of their creative values with the help of the ingenuous and intelligent incorporation of their creative virtues into the stimulation and promotion of the realization of their creative values in future society just as what has been proposed and persisted in the rich theoretical enlightenment and theoretical encouragement epitomized and emphasized in the construction and reconstruction of the theoretical maxims and theoretical rationales of legal naturalism with respect to the insightful liberation of the ideological and epistemological barriers that are inclined to stop them to make fullest use of their intuitional and intuitive creative virtues upon the realization of communism in future society where they are expected to be able to get free from the ideological and epistemological dogmatism as has been popularized in previous or present societies in an absolute fashion on account of the great impact of the institutional or intellectual mechanism and ritualism that have been imprisoning them a great deal at present to the extent that most of those living in the past or at present are unable to dream about what will happen to them in the future owing to their conservative insistence on the stupidity they have never been able to figure out in an insightful fashion at the risk of the acceleration of the decadence of man in the long run. In this case, what has to be pointed out in a sensitive fashion and in a sensible fashion is that the devaluation of the creative virtues of man according to the destruction or devastation of natural disasters in a given region and the misfortunes or mishaps of a given group of man in a given region at a given historical moment, is, a logical fallacy that is unlikely to stand the test of the logical inference grounded on the objective

facts and authentic data exemplified in the real living experiences and working experiences of them in an evident fashion, the excessive exaggeration of the ubiquitous and unanimous impotence of man in a pessimistic fashion has indicated in an implicit fashion that those who have attached too much importance to the impotence of man tend to owe too much of their perceptive and conceptive failure or inability of the essential and authentic existence and essence of man to the philanthropic powerlessness and helplessness of the society in which they live at present in a simplistic fashion and in a superficial fashion just as what has been exemplified in the futility the great efforts Raymond has made to change the miserable existence of the painful lots and lives of his wife Perdita in an omnipotent fashion. The true logical implausibility of this fallacy has made it very evident that the overall application of the valuable ideological and epistemological enlightenment and encouragement of man is inclined to give them an appropriate and adequate impetus to the growing intensification of the perceptive and cognitive stimulus valuable for them to seek for the maximization of the creative imagination, creative inspiration, and, creative illumination to enable them to make a very good ideological and epistemological progress to make a perceptive and cognitive preparation for the acquisition of their essential transcendence in the future society just as what has been shown in the active exploration the protagonist has made of the unknown shores at the end of this science fiction to help himself get adapted to an unknown world to enrich his ideological and epistemological pursuits, to broaden his perceptive and cognitive horizons, and, to particularize their further and future perception and cognition of the creative virtues of man in an optimistic fashion, in an impressive fashion, and in an insightful fashion with the help of the insightful inspiration and illumination that are in a position to be dug out from the theoretical imagination and theoretical illumination implied in the realization of communism in future society where the cultural virtues of man are going to be placed a great emphasis on in a popular fashion.

Then, notwithstanding what has been impressed in an apparent fashion in the previous and present interpretation that has been given of the simple and superficial perception and cognition of the crucial critical versatility, critical validity, and, critical variability of man on which this science fiction titled *The Last Man* has been imprinted in an euphemistic fashion to highlight the critical confidentiality, critical impersonality, critical objectivity, and, critical impartiality personified in the successive and sustainable stimulation and promotion of the strong critical motivation and critical intention developed and improved in the aesthetic and artistic interweavement of the narrative components of this science fiction to euphemize and emphasize the narrative conscience the writer of this science fiction intends to instilled into the narrative frameworks, narrative structures, narrative plots, and, narrative systems of it either in a conscious fashion or in an unconscious fashion as a result of the popular disconnection of the analytical practices and analytical processes related to the analytical elaboration of the narrative phenomenon that has characterized the narrative facts and narrative events which this science fiction has been composed of either in a regular fashion or in an irregular fashion to reach a kind of analytical target designed to meet the needs of making an exploration of the predictable or unpredictable vision of future society based on what has occurred to the author of this science fiction in this journey and what has spoiled his mood

before or after it with respect to what has happened to her in an unfortunate fashion, and, the ignorance of the logical inappropriateness and incorrectness for her to take a good look at what to come into being in the future in accordance with what has happened to her at present on account of what she has suffered from the social reality, cultural reality, historical reality, as much as, psychological reality she has to be faced with whether she is willing to embrace them or not regardless of her innocent ignorance of the harm this predictable or unpredictable imagination of the extinctive crises of man is inclined to do to the experiential and experimental growth of the virtuous perception and cognition of a variety of readers in that this imagination is likely to give rise to the preconception or misconception as are inclined to throw them into the danger of the pessimistic criticism or escapist cynicism in view of the critical inclinations of man in future society, it is of great analytical importance for the author of this article to make a rational analysis of the authentic reality and realistic cruelty a good many literary scholars or literary critics have to be faced with either in a voluntary fashion or in a compulsory fashion, and, to give a clear picture of the critical virtues of man in an objective fashion and in a logical fashion for the aim of showing an optimistic concern for the lots and lives of man as shown in the critical inspiration and critical imagination the protagonist of this science fiction by the name of Lionel Verney has been developed and improved to hold an optimistic attitude toward the overall and adequate development and improvement of the critical potentiality of man and to have a great faith in the stimulation and promotion of their critical passion to send their contribution to the logical linearization and literal liberalization of the critical thoughts and critical insights that have come to their minds either in a traceable fashion or in an untraceable fashion to enable him to highlight the critical conscience of man in an objective fashion and in an intuitive fashion even though he has caught sight of the fatalistic death of most of the team members of his traveling team especially those two characters, namely, Adrian and Evadne who have been tortured in an unbearable fashion in either the affective or marital strains that have made them taken no interest in their lives, let alone the critical interest in everything showing up in their lives due to their disappointment or desperation at the good the gloomy sentimentalism and pessimism of their minds are likely to do to the appropriate refreshment and refinement of the critical encouragement and critical enlightenment that can be made best use of in a successful fashion and in a sufficient fashion to highlight their critical virtues to help them to make their way to the essential transcendence of them in a beneficial fashion. At the thought of the excessive exaggeration of the critical impotence of man in the empirical and practical experimentation of those characters, it has turned out to be very fortunate to sense it in a clear fashion that the protagonist of this science fiction named Lionel Verney has turned out to be exempt from the extensive popularization of the increasing devaluation and distortion of the critical meritocracy and critical supremacy of man in a blind fashion, and, chosen to set his foot on the way to the unknown shores unvisited by his traveling team and to make a new exploration of what has failed to be known to him in an unknown world in a decisive fashion, in an ambitious fashion, and, in an aggressive fashion in spite of his verbal failure to show his critical comments on what has been implanted into the minds of the rest members of his team in a direct fashion. It is in a position to be sensed in the perception and

cognition of his actions that his behavioral response to what has been persisted in a dogmatic fashion in those members who have been caged in the short sight or hindsight of the known world, has turned out to be an apparent sigh as has suggested in an euphemistic fashion that he has kept in his mind that he is supposed to make a critical judgment of what to happen in the future by himself in an insightful fashion in lieu of being lost in the very simplistic and superficial domination, manipulation, or, even stupefaction of those members in a mechanical fashion, in a ritualistic fashion, or, in a sycophantic fashion. In a theoretical sense, his action is in consistent with what has been proposed in the continuous theoretical experimentation and exemplification of legal naturalism with regard to the very insightful and ingenuous development and improvement of the critical intelligence, critical persistence, and, critical transcendence of man in the future in a profound fashion, in a particular fashion, and, in a perspicacious fashion. In a conclusive sense, what has to be known from this analytical clarification connected with the combination of the euphemistic critical spirits and critical thoughts of the protagonist of this science fiction and those suggested in the theoretical construction of legal naturalism has turned out to be fitting in with the objective justification of theoretical and practical feasibility for the genuine realization of the essential transcendence of man in terms of their critical virtues as have been elaborated above in a respective fashion.

Finally, with the standpoint of the polemicist subversion of the cautious personality of man that has been repressed in the same pace kept in with the upcoming absence of the cautious awareness, cautious spirits, and, cautious pursuits of them as a result of the popular exaggeration of the thorough extinction of man in accordance with the superficial observation and examination of the fragile lots and miserable lives of the characters depicted in the ideological and epistemological characterization of this science fiction under the title of *The Last Man* with little concern shown for the plausibility and possibility of this excessive exaggeration in a logical sense in spite of a good look having been taken at the genuine existence of man in combination with the experiential phenomenon and experimental phenomenon that have turned up in the exploration they have been making of the authentic and objective existence and essence of the social reality, cultural reality, historical reality, psychological reality they are supposed to be faced with in the objective world where they have lived on a daily basis based on the perceptive and cognitive inadequateness, inaccurateness, and, inappropriateness the interpretative practices and processes of a wide variety of literary scholars or literary critics have been characterized with owing to the increasing permeation of the perceptive and cognitive pessimism and escapism into their minds in the process of their interpretation of the perceptive and cognitive mentality and spirituality of the major characters depicted in the production of this science fiction in association with the narrative facts and narrative events on which the lots and lives of them have been imprinted in a conspicuous fashion at the risk of the impact the perceptive and cognitive irrationalism of those literary scholars or literary critics is inclined to have on the perceptive and cognitive growth of most readers of this science fiction to make them take it for granted either in an ignorant fashion or in an innocent fashion that little is in a position of be expected of the profound and perspicacious development and improvement of the critical thinking of man in lieu of that of those literary scholars or literary critics and the critical writing of the writer of this science fiction who has failed to prevent herself from the implantation of her personal disappointment or even desperation at the miserable existence and misfortunate experience she has gone through in her own lives that tend to give rise to their social cynicism, cultural cynicism, as much as, historical cynicism due to the deteriorations of their increasing sentimentalism, what is supposed to be noted in a critical fashion in the rational reflection and rumination of what has been instilled into the narrative variables and narrative parameters of this science fiction is that the pessimistic subversion of the true cautious particularity, cautious profundity, cautious predictability, and, cautious perspicacity of man of which the cautious personality of them has been composed in an inclusive fashion, is not very favorable for the successive and sustainable development and improvement of the cautious virtues of man in the case of the systematic and strategic fertilization of ideological and epistemological ground for the refreshment and reinforcement of the extent to which it is possible for them to make their way to the profound and particular perception and cognition of the cautious awareness, cautious spirits, and, cautious pursuits it takes them to lay a sound foundation for the insightful and ingenuous stimulation and promotion of the reflective and ruminative judgment to be made of the theoretical and practical feasibility for the maintenance of and the persistence in the cautious virtues of them in a decisive fashion, in a diverse fashion, and, in a distinctive fashion when they are told in a plausible fashion or in an implausible fashion that they have to be faced with the thorough extinction of their objective and essential existence on the earth, for this subversion is inclined to deprive them of the true cautious sensibility and cautious sensitivity to confirm the actuality and authenticity of this so-called pessimistic extinction of man before they take it from this excessive pessimistic perception and cognition of the true cautious existence and cautious essence of man on the ground of their having made a good analysis of the questionability of this fatalistic extinction in a rational fashion, and the theoretical and practical probability and possibility for this pessimistic devaluation and distortion of the factual existence of man. As a matter of fact, as long as they are able to make them catch hold of the reflective and ruminative quietness to make sure of the rationality and reliability of their analysis of the superficial phenomenon to see through the ideological and epistemological essence and quintessence to be dug out from the questionable exaggeration of the extinction of man in a valuable fashion and in a veritable fashion indebted to the rational quietness that are likely to learn from the protagonist of this science fiction by the name of Lionel Verney who has kept awake in a persistent fashion and in a perspicacious fashion when most of the members of his traveling team are made unawake the moment they have been caught in the terror of the doom of the world in a blind fashion. To this very extent, it can be seen in a clear fashion that the responses he has given to the complicated situations in which man have to be faced with, the attitudes he has held toward the pessimistic fallacy of the extinction of man, and, the ambition he has kept in his mind to enable or to inspire him to take a first step forward the aggressive exploration of the unknown shore in a rational fashion at the end of this science fiction are in a position to be the most appropriate example he has set for the rest of the members of his team in an unconscious fashion right on the way to the clarification of the optimistic existence and objective essence of the continuation of the cautious views of man he has bodied forth in a symbolic fashion and in a strategic fashion. Moreover, it has to be noticed in a very reasonable fashion that his questionable reflection and rumination of this superficial phenomenon of the extinction of man is also valuable for him to make it consistent with the theoretical feasibility potentiated in the successive and sustainable elaboration and exploration to be made of the essential liberation of man in the construction of the theoretical thoughts and theoretical insights of legal naturalism, for this consistence between the insightful and ingenuous characterization of the cautious virtues of man and the creative exploration of the cautious potentiality of them in the ideological and epistemological enrichment and improvement of them are bound to give a strong perceptive and cognitive impetus to the acquisition of their essential transcendence in terms of the as exemplified in the successive and sustainable development of legal naturalism.

On the foundation of the ideological and epistemological courage and confidence to be dug out from the analytical samples served as the practical evidences for the objective and evident justification of the enrichment and improvement of the views, values, and, virtues of man in the future as proposed in the articulation of the major analytical proposition of this study and the theoretical encouragement and enlightenment potentiated in the increasing theoretical exploration of legal naturalism in the light of the evolution, promotion, and, liberation of man in future society to be used as the theoretical evidences in the systematic and strategic justification of the major analytical justification of this study, it has been seen in an apparent fashion that according to what has been exemplified in the three analytical steps that have been taken for the clarification of the theoretical and practical feasibility for the essential transcendence of the views, values, and, virtues of man in reference to what has been mirrored in the narrative facts and narrative events diversified and personified in the production of this science fiction, and what has been euphemized in a wide range of theoretical nutrients of the theoretical thoughts and theoretical insights of legal naturalism pertaining to the very rich imagination and inspiration of the evolution, promotion, and, liberation of man in future society, it can be concluded in a clear fashion that the appropriate and adequate incorporation of the stratification and systematization of the practical evidences found out from this science fiction into the overall and profound reflection and rumination of the theoretical evidences perceived and conceived from legal naturalism has made it quite evident and adequate for the clarification of the theoretical and practical potentiality of the essential transcendence of man with regard to their views, values, and, virtues to be achieved in future community society from the point of the profound and perspicacious expectation of the great ideological and epistemological contributions man will send to the successful and sufficient prosperity of future society in the image of communism.

#### 5. Conclusion

In response to that has been given to what has been explored for the appropriate, apparent, and adequate clarification of the devaluation and distortion of the views, values, and, virtues of man in a pessimistic fashion impressed in the previous interpretation of the miserable existence of the characters depicted in this science fiction and the great efforts made in this study to give a very clear picture of the views, values, and, virtues of man in an optimistic fashion in organic combination with what has been illuminated in the very insightful and intelligent articulation of the theoretical construction of legal naturalism regarding the evolution, promotion, and liberation of man, it will be found in the analytical stratification and categorization of the essential progress and transcendence of man as has been rooted in the support of the rich theoretical evidences obtained from the theoretical thoughts and theoretical insights of legal naturalism and the practical evidences picked out from this science fiction in an intentional fashion that although the interpretation of the lives of man in the future in the production and interpretation of science fictions in previous and present studies has turned out to be not far-sighted enough due to the ignorance of the genuine existence, essence, intelligence, and, transcendence of man and the pessimistic expectation of the views, values and virtues of man, what has been made evident in the objective and authentic argumentation of this study is that it will be feasible for the man in the future to acquire admirable ideological and epistemological transcendence to highlight their insightful views, to realize their values, and, to maximize their virtues to send their respective contributions to future society just as what has been expected in the optimistic theorization and optimization of legal naturalism in the light of the evolution, promotion, and, liberation of man to enable them to be faced with the great challenges the successive and sustainable development and improvement of artificial intelligence at present and in the future, for it seems to impress a variety of researchers in an extensive fashion that compared with the growth of the convenience artificial intelligence has given rise to the devaluation and distortion of the genuine confidence of man on the way to the maximization of the contributions man are inclined to send to the true realization of their ideological and epistemological dreams that are likely to give a strong ideological and epistemological impetus to the maximization of their views, their values, and, their virtues in the promotion of the present society and the realization of all the dreams related to the expectation of the future society in a continuous fashion on the ground as has been laid for the appropriate and adequate development of human intelligence and the pace kept in with that of artificial intelligence. In connection with the implications of this exploration, it can be exemplified in the important role the intuitive findings of this exploration is quite likely to play in helping an increasing range of literary theorists to enrich their theoretical thoughts and theoretical insights that are inclined to enable them to show their concern for the lots of man in inclusive fashion when they are faced with the unimaginable adversity coated in the form of prosperity, to inspire a good many present literary critics to broaden their analytical horizons while taking a critical look at the virtues and vices of man in an illusionary way owing to the ideological and epistemological confinement of the pessimistic attitudes held towards man in a cynical fashion, and, to remind a large number of literary readers of the probability that while reading literary works like *The Last Man*, it is of great ideological and epistemological importance for them to place on the authentic and intuitive responses they have given to what those literary works has impressed them in an independent way rather than take it for granted in a blind fashion what they have been told in the dominative and manipulative interpretations of a good many literary scholars who are unable to give a very clear picture of the ideological and epistemological particularity, profundity, and, prosperity of those literary works in an adequate fashion.

In the case of the analytical inadequateness of this study, what has to be kept in the minds of the readers of the exploration made in this article in an honest fashion is that great efforts as have been made in the realization of the analytical profundity, particularity, and, perspicacity of the exploration of the ideological and epistemological superiority of man in an insightful fashion on the basis of the growing accumulation of the analytical imagination and inspiration from the profound stratification of the valuable and veritable denotations and connotations of this science fiction in an ambitious fashion and in an aggressive fashion, it has to be noted in an objective fashion that the analytical simplicity and superficiality of this exploration is very likely to exist in some cases as a result of the denotative and connotative diversity and complexity of the intrinsic and essential thoughts and insights as articulated in the empirical and practical production of this science fiction, the successive and sustainable impact the perceptive and cognitive variety of the actual analytical focuses of a variety of previous literary scholars who have given an account of it from various analytical perspectives has on the genuine overall development and improvement of the analytical superiority of the author of this study, and, the changeable contextuality of the analytical background to which a plethora of analytical experiments many literary scholars have been conducting in a correlative fashion in their academic explication of the ideological and epistemological values of this science fiction.

In view of the analytical suggestions for further studies in relation to the further exploration and explication of the unknown views, values, and, virtues of man indebted to their achievement of the very great success in the essential liberation of their ideological and epistemological independence from the imprisonment of either the noticeable or unnoticeable dogmas, preferences, prejudices and so forth that kept in the minds of those who have turned to be unable to get free from the enslavement of the known views, values, and, virtues to which they have been accustomed in a mechanical way and in a ritualistic way, it has to be suggested in a decisive fashion that those known dogmas are the continuous and mountainous barriers that have been preventing man from the authentic and objective achievement of the essential transcendence of men that tend to give rise to the refreshment, refinement, reinforcement, and, replacement of those known dogmas on the way to their ambitious and aggressive acquisition of the unknown ones in a valuable way and in a veritable way in spite of the unintelligibility of them on the part of those who have been caught in or lost in what has been popularized at present. Difficult as it is for researchers to follow this suggestion, very great efforts will be made in this respect. At last, it is in a position to be claimed in an honest fashion that were offence made to any scholar in this field in a purposeless way, elegant forgiveness would be expected in a respectable way.
