The economy is dependent on imports and their own industries are very weak; the political life is clearly feudal, with military and tribal politics dominating. The main reason for all this is that the traditional way of thinking and acting has become a serious obstacle to people's comprehensive development and stride towards modernization, and once the resources are exhausted, the phantom of economic prosperity will disappear. Of course, we are not denying that there has been no change in the state of the people of these countries, but only that there has been no fundamental change and that the pace of their development has been slow.
