In fact, he was the last truly absolute ruler by divine right; his powers became those of a constitutional monarch from 1791, although they had been so since October 1789.

Initially loved by the people, he supported the American Revolutionary War, but was unable to fully understand subsequent events at home. In the first years of his reign, Louis was a reformist ruler: he abolished serfdom, corvée, torture and the death penalty for desertion, as well as other taxes imposed on the bourgeoisie and the people in favor of the nobles, who were hostile to these decisions, and attempted to improve the finances and situation of France by appointing ministers such as Jacques Necker, the physiocrat Anne Robert Jacques Turgot, Charles Alexandre de Calonne and the Enlightenment jurist Guillaume-Chrétien de Lamington de Malherbe's, finally convening the Estates-General.

Louis XVI was legally rehabilitated, together with his wife Marie Antoinette, guillotined on 16 October 1793, by his brother Louis XVIII with the Restoration (1815) and with the enactment of the law against regicides which punished with exile the members of the National Convention who had voted for the death sentence (1816).

Note 2. On 12 September 1919 Gabriele D'Annunzio at the head of a column of deserters (almost 3,000 "legionaries") entered Fiume, a city inhabited mainly by Italians but whose fate after the First World War was still uncertain. In the following months, the poet-soldier from Abruzzo will combine the patriotic motivations of his enterprise with revolutionary purposes, global palingetic intentions, baits with separatists and subversives from all over Europe and beyond. The constitutional document of the Italian Regency of Carnaro, the State proclaimed by D'Annunzio on 12 September 1920 in the face of the failed annexation to the Kingdom of Italy, will remain in the annals. The constitution of this city-state was the Carnaro Charter, drawn up by the revolutionary syndicalist Alceste De Ambris, perfected and drafted in a courtly manner by D'Annunzio himself.

Note 3. Protests in the U.S. against the usurping tendencies of the President "President thinks his power is absolute. But in America we have no kings and we will not surrender to chaos, corruption and cruelty. Our peaceful movement is getting bigger and bigger. "NO KINGS" is not just a slogan; It is the foundation on which our nation was built. Born in the streets, shouted by millions, carried on placards and songs, it resonates from city neighborhoods to country squares, uniting people across the country to fight the dictatorship together. Because this country does not belong to kings, dictators or tyrants. It belongs to us, the people: the people who care, who step up and who fight for dignity, a life we can afford and real opportunities. No thrones. No crowns. No king".

Note 4. Femicide in Milan, Pamela Genini killed with 24 stab wounds. A 29-year-old woman was killed with 24 stab wounds on the terrace of her home by her 52-year-old partner with whom she had been in a relationship for about a year. "She had decided to leave him," says those who knew the couple well. He would have attempted suicide after stabbing the victim, but it would not be life-threatening. The man was arrested for aggravated murder on the orders of the prosecutor on duty.

Note 5. Article 3 of the Italian Constitution represents one of the fundamental principles on which the legal system of our country is based. It enshrines the principle of equality, both formal and substantive, between all Italian citizens. This constitutional article represents a fundamental point of reference for the protection of the rights and freedoms of every individual, guaranteeing equality before the law and prohibiting all forms of discrimination.

Preamble dela constitution USA: We, the people of the United States, in order to form a more perfect Union, establish justice, insure domestic tranquility, provide for the common defiance, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America.

On the unwritten English constitution.

- Magna Carta (1215): Considered one of the first documents establishing the rights of citizens against monarchical authority.
- Bill of Rights (1689): It marked the beginning of constitutional monarchy in England, establishing fundamental rights and limiting the powers of the sovereign. In summary, the Constitution of the United

Kingdom is a complex set of laws and practices that have evolved over time, reflecting the country's history and traditions, without the need for a formal constitutional document.

The constitution of Germany has its origins in the German defeat in the Second World War with the consequent fall of National Socialism. In 1945, the Yalta conference had in fact laid the material foundations for the division of Germany into two states. At the time it was promulgated on May 23, 1949, the constitution came into force only in West Germany; it was considered provisional pending German reunification. This is the reason why it was not called "Constitution" (*Verfassung*), but the current name was chosen. At the time of the reunification of Germany, it was decided to maintain the Western constitution: in fact, West Germany proposed itself as the sole heir of the German Reich, while the results of the elections of the DDR, now collapsing, were interpreted as an expression of the desire to rejoin the Federal Republic of Germany as soon as possible, therefore with West Germany.

Note 6. The phrase "post poenam" is Latin and appears in your document in the context of legal and rehabilitative processes. In this context, "post poenam" refers to the period after the punishment (i.e., after a person has served their sentence). The document discusses how, after serving a corrective prison sentence and being recognized as mentally healthy, an individual should have their full rights restored—this is the "post poenam" phase, meaning after the penalty or after the sentence.

Note 7. Raffaele Marianella, the driver killed by the throwing of a large stone by violent ultras after the match between Pistoia and Rieti of the men's A2 series basketball championship, worked for a long time at the Giotto Bus vicchiese Giotto Bus, until the spring of last year. The tragedy happened on Sunday evening, October 19, just before 21.00, on the state road 79, which connects Rieti to Terni. Note 8. Psychomotor agitation is a state of physical restlessness and mental distress, marked by purposeless movements like pacing or fidgeting, and often accompanied by an inability to relax. It is a symptom of various conditions, including psychiatric disorders like bipolar disorder and schizophrenia, substance use, and neurological issues, and can be a medical emergency requiring professional attention. Treatment focuses on managing the underlying cause and can include creating a calm environment, simplifying tasks, and professional medical and psychological support.

Note 9. In summary: neurological hyperesthesia is a symptom of nervous system dysfunction, often associated with neurological diseases, infections or nerve injuries, and always requires medical evaluation for proper diagnosis and treatment. The link between **hyperesthesia** (hypersensitivity to stimuli, both physical and emotional) and **violence** is complex and involves several neurological and psychological aspects.

1). Neurological hyperesthesia and aggressive behaviors: - Hyperesthesia can be a symptom of dysfunction of the central or peripheral nervous system, often associated with neurological diseases,

infections, trauma or psychiatric disorders. humanitas. - In some psychiatric disorders (such as antisocial personality disorder, schizophrenia, bipolar disorder in the manic phase), emotional hyperactivity and difficulty in regulating impulses can lead to aggressive or violent behavior. Microbiology. - States of psychomotor agitation, characterized by emotional and motor hyperesthesia, can lead to violent behavior, especially if not adequately managed or treated psychiatryonline.

- 2). Emotional hyperesthesia and emotion regulation: Emotional hyperesthesia (hypersensitivity to emotional stimuli) can make some people particularly reactive to stressful, frustrated or conflictual situations. Difficulty in emotional regulation is a risk factor for reactive aggression: those who cannot manage intense emotions may respond with anger or violence to stimuli that others would find tolerable. Studies show that low levels of emotional intelligence and self-control are correlated with a higher likelihood of aggressive behavior-tesionline.
- 3). Social and environmental factors: -Emotional hyperesthesia can be accentuated by traumatic experiences, toxic relationships, substance abuse, or chronic stress, increasing the risk of violent behavior. psicologajessicaferrigno. Violence is never the result of a single factor, but of a combination of biological vulnerabilities, emotional difficulties and unfavorable social contexts

Note 10. For example, Durkheim, considered the father of the sociology of education, argued that education depended totally on society as society was configured as the moral authority that bound and attracted individuals to itself, in fact he stated "every society considered at a given moment in its development has a system of education that imposes itself on individuals with a generally irresistible force". This means that, according to Durkhaim and according to this model, culture imposed itself on educational processes, determining this relationship between society and education in terms of dependence. In addition to Durkheim, Marx, Weber, Simmel, Mannheim and Parsons were part of this perspective, who understood education as a dependent variable of society and educational institutions and processes as determined by the social conditions of reference.

Note 11. Symptoms like hallucinations, delusions, and scattered thinking can make it hard to hold a job. People with schizophrenia are six to seven times more likely to be unemployed than those without this condition

Note 12. The Battle of Actium (2 September 31 BC) was a naval battle that ended the civil war between Octavian and Mark Antony, the latter allied with Cleopatra's Ptolemaic Kingdom of Egypt. The naval battle was won by Octavian's fleet, skillfully led by Marcus Vipsanius Agrippa, also due to the poor decision of Mark Antony who, while the outcome of the fight was still uncertain, was persuaded by Cleopatra to flee to Egypt with part of the ships.

Note 13. Pax Romana - a long period of peace imposed on the states within the Roman Empire thanks to the seizure of power by Augustus and for this reason also called *Pax Augustea*.

The expression derives from the fact that Roman rule and its legal system pacified the regions that had suffered from disputes between rival chiefs. During this period, however, Rome fought a number of wars against neighboring states and tribes, especially the Germanic tribes and Parthia. It was an era of relative

tranquility in which Rome suffered neither the great civil wars, such as the perpetual bloodbath of the first century BC, nor serious invasions, such as those of the second Punic war of the previous century. We know that Augustus ordered in 11 B.C. to place a statue in honor of Pax in Rome.
